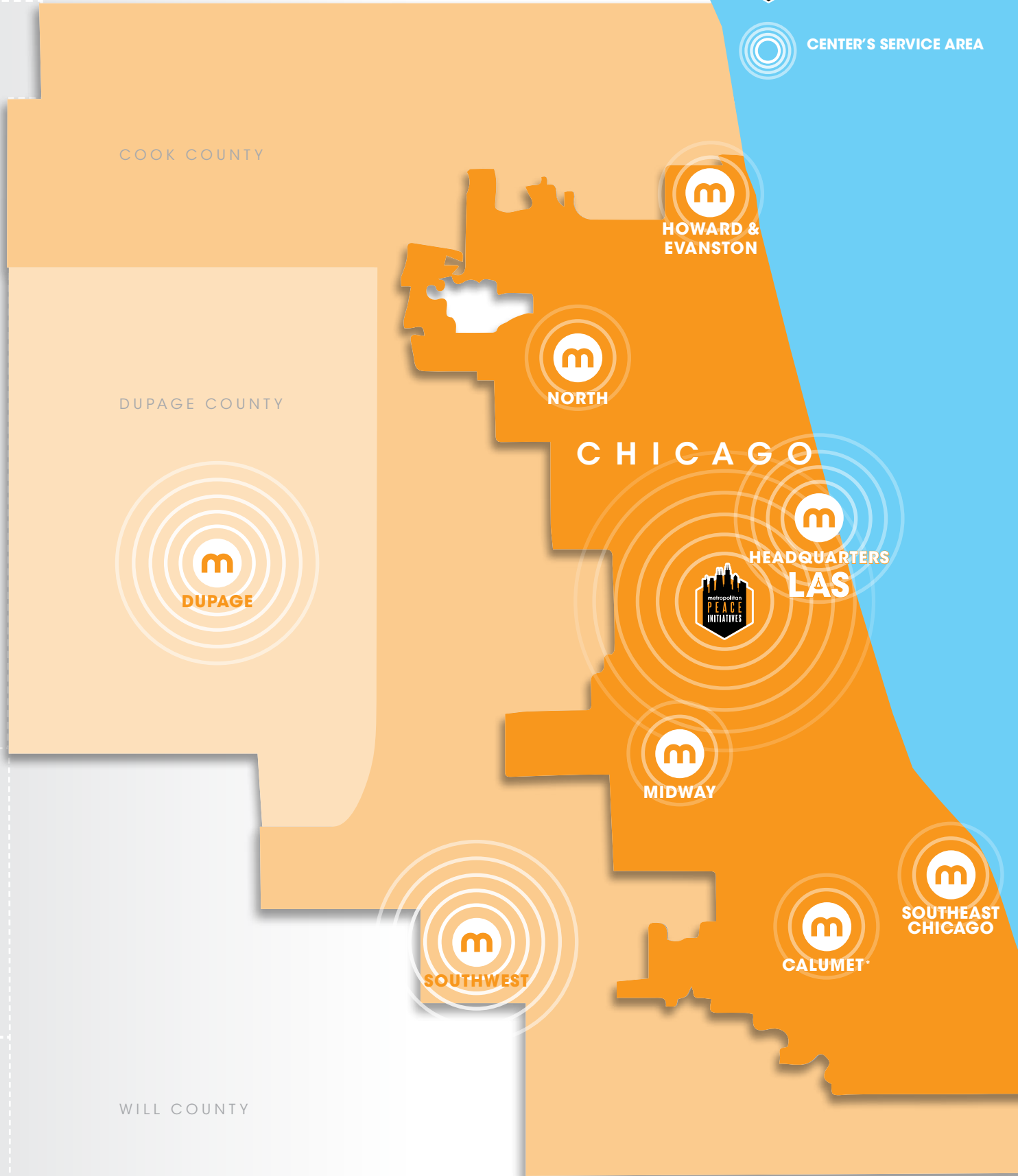

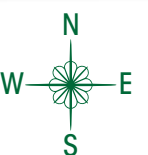

From our CEO AND BOARD CHAIR

Continued growth – spurred by opportunity and delivering results – generated a banner year for Metropolitan Family Services (MFS)! We are honored to say that we now Mpower 183,601 families and individuals throughout Cook and DuPage Counties, and other regions in Illinois, with a team of more than 1,500 full- and part-time staff.

Much of that growth occurred through Metropolitan Peace Initiatives (MPI), Chicago's leading Community Violence Intervention (CVI) collective, and the Calumet Center, an anchor for families throughout the city's far South Side.

As a result of Calumet's success in partnering with the Chicago Housing Authority for 17 years, Calumet was chosen to provide case management services for all of CHA's senior housing. The Center also has expanded its support services for domestic violence survivors needing housing, along with youth employment programming.

Our biggest growth has come through Metropolitan Peace Initiatives (MPI). We're excited to report that MPI's Metropolitan Peace Academy (MPA) Center opened in January 2024. The MPA Center is a state-of-the-art facility, located in Chicago's Pilsen community (which was selected for its central location). With classrooms and meeting spaces equipped with the latest technology, to its podcast recording studio and Peace Room, MPA is a customized space where students, staff and Chicago's CVI community work together to help make the city safer.


MFS is at the forefront of multiple emergency issues impacting our city. With the influx of thousands of new arrivals from Venezuela, our Legal Aid Society (LAS) was selected by the City of Chicago to lead management and dispersing of city funding for legal services assisting new arrivals, and to process asylum and work authorization applications. In addition, our Midway and North Centers (along with LAS) are Illinois Welcoming Centers, serving as hubs that facilitate the integration of new arrivals, immigrants and refugees into the state.

MFS continues to provide critical services to our clients through our 10 community centers. From preparing first-generation college-bound teens for success, to providing counseling and services that help clients care for spouses who have dementia, we strive to be where clients need us. Turning College Dreams into Reality: THE IMPACT OF TRiO UPWARD BOUND

The TRiO Upward Bound program is designed to make higher education accessible for low-income and first-generation students through focusing on college readiness, securing financial aid, tutoring, and more. By offering essential educational and supportive services from 8th grade to five years post-high school graduation, this program helps students navigate the complexities of the college application process.

"We are keeping track of their scholarships dollars, their financial aid, the schools that they are applying to, and for our underclassmen, gage what interests that they have," explains Katie Johnston, a Case Manager in TRiO Upward Bound. "We are creating trips and experiences that help broaden their idea of what college can look like for them and what they can see themselves doing in the future."

"I feel that the program has empowered me, it's given me more confidence. I wouldn't say I'm a shy, timid person, but it takes me a while to adapt, but these people made me feel so comfortable, I was able to express myself. It's given me a new sense of self in a way, it's amazing."

Isis Haley, an Upward Bound participant, is a rising senior at Brooks College Prep, hoping to attend Texas A&M next year. She found the program when Katie visited her high school. "[The program] offers college tours and SAT prep, and just tutoring in general," she says, explaining why she joined. "In the summer program, we have been doing the necessary things to prep for college. My dreams have always been to go to college but now it feels more tangible, and I know they have helped other people get there so it's reassuring."

But Upward Bound doesn't just focus on getting youth accepted into college – it supports them so they can see it through to graduation.

Another Upward Bound student, London Jackson, is a rising senior at Kenwood Academy High School, who recently became a 2024 Cubs Scholar after applying for the \$20,000 scholarship through the Upward Bound program. "I didn't know how everything worked," he explains. "Like grants, I had no idea what a grant scholarship was until I got here. I've just gotten a lot of great experiences and overall opportunities." London plans to enroll in college next fall, hoping to study fashion design, fashion and business, or sports management.

Over its 18-year history, TRiO Upward Bound has empowered countless students across five Chicago high schools, turning dreams of college into reality. "Seeing those acceptances come in, seeing those scholarships come in, they are blooming right before your eyes and being with them every step of the way is honestly an honor," says Katie.

"In this program I met a lot of great people. We have done workshops and college tours, which were great. We did resume help, portfolio help and personal statement work. Those were all great experiences. I didn't really think I'd have the opportunity to do so otherwise."

Breaking Barriers: HOW HECC'S ADULT EDUCATION PROGRAM OPENS DOORS

With a comprehensive approach that includes English language instruction and GED preparation, the Adult Education program at the Howard & Evanston Community Center (HECC) is designed to equip adults who have immigrated to the United States with the skills necessary for career success and integration into their communities.

"Not only are we providing some fundamental skills in education, basic language and numeracy, we are also preparing adults to contribute at a family level and a community level," explains Jason Kaiser, Executive Director of HECC. The Adult Education program has served clients across 64 countries and 42 different languages, providing five levels of English language instruction and GED prep classes. "These are the foundational skills that are necessary to progress further in areas that they need to provide for their families," he says.

While Jason began his journey with HECC as a volunteer in the Adult Education program, instructor Mariela Rodriguez began hers as a student after she immigrated from Venezuela to the United States. In Venezuela, Mariela was a Professor at the University of Carabobo for fifteen years. Upon relocating to the U.S., Mariela enrolled in HECC's Adult Education program GED class, then began taking English classes to improve her speaking, writing and reading comprehension. In the program, she went on to be awarded the Seabury Scholarship, which she used to attend Truman College.

Now, Mariela is an instructor in the Adult Education program. "I can connect with the students regarding the fear and uncertainty that comes with being an immigrant, I can feel what they feel," she explains. "What I'm doing today is because I got a great foundation from my country. And now, I'm giving part of that to my students."

Building Foundations: MIDWAY'S HEAD START PROGRAM

The Midway Children Center (MCC) is a Head Start Early Childhood Education Program, which is a full-day initiative that supports children aged 2 to 5 years. It focuses on teaching hands-on activities, social skills development, learning through language, motor activities and more, through fun and engaging ways. The program provides a nurturing environment where children can thrive and build a strong foundation for future learning.

Jacqueline Mosley has been a teacher at MCC for the past fourteen years and goes by Ms. Jackie. Growing up with many siblings, she realized at a young age she wanted to become a teacher. “Someone has to be there for the babies, and one of those people is me, until I retire!” she laughs. “Once I’m in the classroom I’m in a whole different world, it’s my world.”

Angelica Gamino met Ms. Jackie when she enrolled her two sons, Ethan and Aiden, into the program. When Ethan first started, he was very shy and would bite his fingers around other children. Angelica recalls when she noticed Ethan had stopped the behavior, saying, “That’s when I knew they were in good hands. They really were cared for. They trusted the teachers, and they were happy with the kids.”

As Ethan continued in the program, his vocabulary expanded, and he became more outgoing, socializing and playing with other children. His older brother, Aiden, also thrived at MCC, and by the time he transitioned into kindergarten, he was reading to other students. Angelica attributes their success to the program’s focus on socializing, sharing, and early learning.

Caring for the Caregiver: HOW SENIOR COUNSELING SUPPORTS FAMILIES

The Senior Counseling program is designed to assist older adults and their caregivers by giving them support during vulnerable moments in their life. It offers a comprehensive suite of services including in-home and office assessments, family and individual counseling, support groups, case management, and connections to valuable resources, which are key avenues of support for clients like Cindy King.

Cindy is her husband Gary's full-time caregiver. She was connected with Kathleen Drouin, a counselor with the program, through her daughter, who had been searching for resources to support her mother after Gary was diagnosed with Alzheimer's. Kathleen has been working with Cindy for five years, providing her with much-needed support and guidance as she transitioned into becoming a full-time caregiver.

"It's nice to have someone to talk to who understands what you're going through," Cindy shares. "Most people don't realize everything that's going on."

Kathleen encouraged Cindy to enroll Gary in a daycare program. Though Cindy was initially hesitant, the daily activity has been remarkably positive for both Cindy and Gary. "The people there are wonderful; they keep him busy all day long," Cindy says. The daycare not only provides Gary with stimulating activities but also allows Cindy crucial time for self-care—a vital aspect of caregiving that can often be forgotten.

Beyond daycare, Kathleen also introduced Cindy to an Elder Care Attorney, who helped Cindy organize her and Gary's future plans and finances. She has also provided Cindy with resources, including books about Alzheimer's, and offered practical tips and strategies. Monthly meetings with Kathleen have allowed them to address ongoing issues and plan for long-term care, such as taking Gary's picture to the police station in case he goes missing.

"Kathleen just helps me all the time," Cindy laughs. "I would recommend MFS to anybody. Having someone to talk to is so important because no one else really understands unless they are living the situation."

Doing the Work, Leading the Work

A YEAR OF EXPANSION & RECOGNITION



EXPANSION

- **Metropolitan Peace Initiatives (MPI) has grown 51% in the last year** in support of our 15 Communities Partnering 4 Peace (CP4P) partner organizations, helping each build capacity and increase comprehensive service delivery in the 28 communities we serve. The Metropolitan Peace Academy, Behavioral Health Services, Workforce Development, CP4P Justice Corps, Program Operations, Program Evaluation, Accounting, Policy & Advocacy, Communications, and Program Services teams have all experienced exponential growth.
- **MPI welcomed two new organizations into CP4P** — Public Equity and Think Outside Da Block. These groups, both serving the Englewood area, joined 13 other community-based and citywide organizations dedicated to helping heal Chicago's communities experiencing the highest levels of gun violence.
- **MPI opened its doors to the Metropolitan Peace Academy (MPA) in Pilsen.** The location serves as a community violence intervention (CVI) training and wellness center for Outreach Workers, Case Managers, Victim Advocates, and Trauma Recovery Specialists. The site also holds community trainings for Chicago residents and police officers. Additionally, the MPA features a gym, cafe and lounge area, peace room, podcast studio, two original murals, and more.
- **In FY24, the MPA graduated 81 Street Outreach Workers, 42 Victim Advocates, 33 Case Managers, and 20 Crisis Prevention & Response Unit (CPRU) Crisis Responders.** To date, more than 500 graduates have passed through the MPA since its inception in January 2018.
- **MPI/CP4P and other Chicago-area CVI groups unveiled "Scaling Community Violence Intervention for a Safer Chicago" (SC2),** a plan to scale coordinated efforts between CVI groups, philanthropic, business, and government leaders in order to reduce gun violence across the city. SC2 is expected to roll out over the next decade and has already received hundreds of thousands of dollars in private and public funding.
- **MPI acquired the Rapid Employment and Development Initiative (READI),** a CVI effort formerly headed by Heartland Alliance. The program prioritizes those most at risk of gun violence, providing them with cognitive behavioral interventions, paid transitional jobs, and wrap-around support services.
- **MPI organized a youth intermediary** in collaboration with Chicago Public Schools and the Mayor's Office of Community Safety to support youth of highest promise, aged 14 to 21. These individuals meet the criteria of being disengaged from Chicago Public Schools for 3+ months or a history of chronic absenteeism; Juvenile Justice system involved; and/or have experienced the effects of violence in their communities.
- **The F.L.I.P. (Flatlining Violence Inspires Peace) program was expanded,** which is designed to utilize a street outreach approach combined with enhanced professional and mental health training. This initiative addresses a citywide need for crisis response to teen trends, mass shootings, large gatherings, and civil unrest.

RECOGNITION

- **CP4P was proven to have an impact in reducing gun violence in Chicago**, according to a report from the Center for Neighborhood Engaged Research and Science (CORNERS). Key findings from the evaluation showed CP4P: 1) reaches the right people; 2) lowers rates of gunshot victimization among participants; 3) improves access to employment, education, and other services; and 4) leads to safer neighborhoods.
- **Governor J.B. Pritzker and Illinois lawmakers approved** the state budget, which includes nearly \$175M toward CVI efforts through the Reimagine Public Safety Act (RSPA). Governor Pritzker has since declared that “CVI is where it’s at” and has called for ongoing funding.
 - **The CPRU oversaw 21 deployments across Chicago** from January 2024 to June 2024, helping to reduce arrests, reduce victimizations, and link high-risk individuals to appropriate resources. The CPRU team was officially launched in FY24.
- **Three CVI professionals representing CP4P graduated** from the inaugural cohort of The University of Chicago Crime Lab’s Community Violence Intervention Leadership Academy (CVILA). The educational program, praised by Vice President Kamala Harris, is aimed at improving the effectiveness of CVI organizations and supporting their mission to reduce gun violence.

- **MPI and the work of CVI saw increased media recognition** from outlets such as the Chicago Tribune, *Chicago Sun-Times*, *Crain’s Chicago Business*, *The Trace*, CBS 2, NBC 5, ABC 7, and more. MPI staff also spoke at events such as the Giffords Community Violence Intervention Conference and the Department of Justice’s Community Based Violence Intervention and Prevention Initiative Grantee Conference. Additionally, MPI Executive Director Vaughn Bryant testified before the U.S. Senate Judiciary Committee on the gun violence epidemic.
- **CP4P was the recipient of the 2024 Distinctive Innovation and Social Service Award** from the University of Chicago Crown Family School of Social Work, Policy and Practice. The accolade is given annually to deserving social service agencies and programs that demonstrate innovation in their approaches and practices while reflecting the mission of the school.

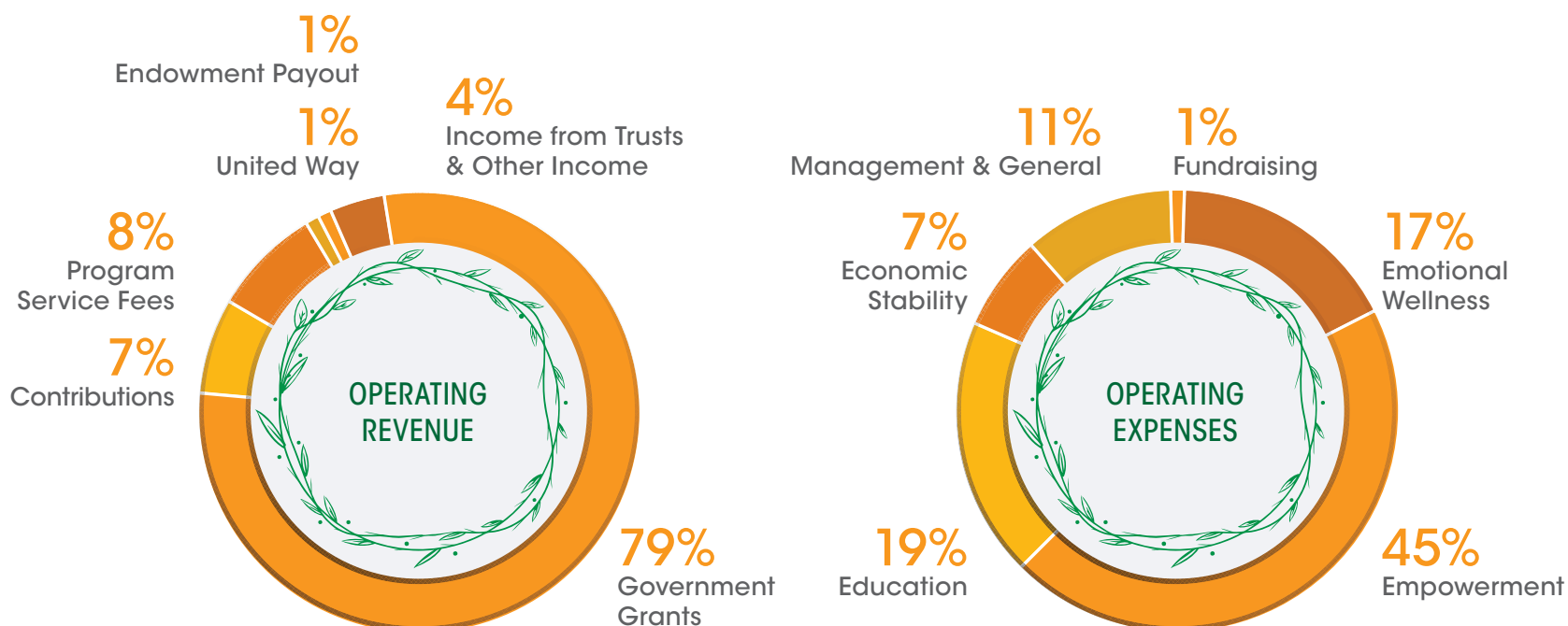
